

2024 EQUINE AFFAIRE RAFFLE W. SPRINGFIELD, MA

OFFICIAL RULES & REGULATIONS

1. **NO PURCHASE NECESSARY.** Open to residents of the United States of America, age 18 or older as of November 11, 2024. This promotion is subject to all applicable federal, state, and local laws and regulations and is void wherever prohibited or restricted by law.
